Target Group: Young people aged 12-25

Escape the Trap is a powerful programme designed to support young people in recognising and avoiding unhealthy relationships. It is especially relevant for school, college and university students, as well as younger parents.

Over eight weeks the programme addresses:

- young peoples' expectations of their intimate relationships
- the behaviours and beliefs of those who treat them badly
- identifying the things abusive partners may say and do to them
- the experience of coercive control & bullying
- the switching of tactics
- emotional abuse, sexual coercion and abuse
- how this behaviour impacts the way young people might feel about themselves, their mental health and emotional well-being
- feeling isolated and alone, guilty and to blame for what is happening to them
- how to identify such behaviour early on in a new relationship

Court IDVA service expands across Thames Valley



Reducing the Risk of Domestic Abuse is proud announce the expansion of our dedicated Court IDVA (Independent Domestic Violence Advisor) service – previously operating successfully in Oxford - across the wider Thames Valley region, thanks to additional funding from the Police and Crime Commissioner (PCC).

This expansion will focus on High Wycombe Magistrates' Court, Aylesbury Crown Court, and both Magistrates' and Crown Courts in Reading.

Our Oxford-based service has already made a meaningful difference, particularly in supporting victim-survivors when Domestic Violence Protection Notices and Orders (DVPN/Os) are issued. We are now extending this vital support to Reading and High Wycombe Magistrates' Courts, where the majority of DVPOs are processed.

To meet growing demand, we have recently welcomed two new Court IDVAs to our team, with the goal of being fully operational by September.

Beyond DVPO-related support, our expanded service will assist victim-survivors involved in both criminal and civil proceedings.

Referrals can be made directly by individuals or through professionals using our streamlined online referral forms on our <u>website</u> Reducing the Risk of Domestic Abuse.

<u>Changing systems, saving lives – Our strategy 2025-2028</u> - Surviving Economic Abuse

Surviving Economic Abuse's three year strategy to drive legal and policy reform and systemic change in frontline, financial and public services to support victim-survivors, disrupt abusers, and prevent economic abuse.

<u>Developing a combined measure of domestic abuse,</u> <u>sexual assault and stalking, England and Wales: July</u> 2025 – Office for National Statistics

The Office for National Statistics has published and refined a new combined prevalence measure for domestic abuse, sexual assault and stalking in England and Wales, designed to give a more accurate, integrated picture of these interconnected harms and to underpin the Government's ambition to halve violence against women and girls within ten years._

Estimating the costs of Sexual Violence – VISION and the Women's Budget Group

New calculator tool to estimate the lifetime cost of the burden of sexual violence and abuse in children and adults by national population and local area in England and Wales.

<u>Domestic abuse in later life: A secondary analysis of the Crime Survey for England and Wales</u> – Prof Hannah Bows

New research on domestic abuse of older people by Professor Hannah Bows from Durham University is the first analysis of data on domestic abuse of adults aged 60-74 years old using the Crime Survey for England and Wales.

Nineteen More Child Homicides - Women's Aid

The third report published by Women's Aid, this report tells the stories of children who have been killed by a parent who is a perpetrator of domestic abuse through child contact (formally or informally arranged).

<u>Verge of Harming Phase 2 resource: Empowering Engagement</u> – SafeLives

An evidence-based practice resource for professionals, developed from the evidence of the *Verge of Harming Phase 2* research report. The resource is recommended when supporting young people aged 10-25 who are using harmful behaviours in their intimate or family relationships.

<u>Domestic Abuse Duty for Support in Safe</u> <u>Accommodation: Evaluation</u> – Gov.uk

Findings from a 3-year evaluation of Part 4 of the Domestic Abuse Act 2021 assessing its delivery, impact and value for money.

<u>Counting the Cost: The Scale and Impact of Economic</u> <u>Abuse in the UK</u> – Surviving Economic Abuse

This landmark research reveals that one in seven UK women – equivalent to 4.1 million women – experienced economic abuse from a partner or ex-partner in the past year.

Never again. Again. A review of health recommendations following a domestic abuse related death – Standing Together

The report, analyses recommendations for health services for every domestic abuse-related death review from 2024. 89% of Domestic Abuse-Related Death Reviews included healthcare recommendations.

New Register of Accredited Domestic Homicide Review / Domestic Abuse Related Death Review Chairs — AAFDA (Advocacy After Fatal Domestic Abuse)

The Register of Accredited Domestic Homicide Review / Domestic Abuse Related Death Review (DHR/DARDR) Chairs is a record of Chairs in England and Wales, who are appropriately qualified and trained to undertake Domestic Homicide Reviews (DRHs) / Domestic Abuse Related Death Reviews (DARDRs).

The register has been established by Advocacy After Fatal Domestic Abuse (AAFDA), on behalf of the Home Office. It forms part of the statutory reform of the DHR/DARDR process, which aims to support the completion of reviews to the highest standards and so support real learning and prevention of domestic abuse related deaths in the future.

In the main, the register is for Community Safety Partnerships (CSPs) to access information about appropriately trained and qualified DHR/DARDR Chairs and to identify areas of particular specialism, if required, and for qualified DHR/DARDR Chairs to be able demonstrate their availability for work opportunities and highlight their areas of work.
