

Child Safeguarding Practice Reviews Guidance for Parents and Carers

What is a Child Safeguarding Practice Review?

A child safeguarding practice review is a multi-agency case review carried out by the local safeguarding children partnership looking at the circumstances in which a child dies or sustains serious harm. The review considers how local organisations worked together, what was done, what lessons can be learned for the future and what changes may need to be made. It is not a criminal investigation or public enquiry and its aim is not to place blame but to learn.

Windsor & Maidenhead's safeguarding partnership arrangements brings together the key organisations who work with children and young people to make sure they are working effectively to keep children safe. It includes local health trusts, Police, local authority children's services and schools.

Conducting a child safeguarding practice review is a legal responsibility, therefore, families are not required to give consent. However, we will give you the opportunity to get involved if you would like to.

Who undertakes a child safeguarding practice review?

A panel of professionals from the relevant community and children's social care services, health services, schools, the Police and sometimes other organisations will be set up for each review. An independent person, who has not been involved in the case, will lead the review.

The panel will meet to review information from each organisation or agency that has worked with, or provided services, to the child and their family. The independent author will then prepare a report. This report will detail what lessons have been learnt, identify good practice and make recommendations for all those involved in order to improve services.

How long will the review take?

It usually takes six to twelve months from the start of the review to publication of the report.

How are families involved?

We will give you, the family members or carer, the opportunity to share your understanding of what happened and why, about what worked well and what could have been done differently. You will be offered the chance to talk to the independent person leading the review. However, you do not have to do this if you don't want to.

Any information you provide will be treated confidentially and used to help the review panel build a full picture of what has happened and in turn identify recommendations for change.

You should also be informed when the review is nearly finished so that you have the opportunity to discuss the findings of the review before publication.

What happens after the report is finished?

We will publish the report on our website at https://rbwmsafeguardingpartnership.org.uk/p/safeguarding-children/case-reviews-1.

The report will not give any personal details or information which would identify the child, their family or anyone else involved.

We will then produce an action plan based on the recommendations of the report to make sure improvements are made to the way in which organisations work together to keep children safe. The Executive Steering Group, which oversees the local multi agency safeguarding arrangements for children, will make sure the actions are carried out and have a positive impact.
